

1. This Command Directive (CD) rescinds CD 029. All Eielson-based military and TDY personnel must follow this CD, and I expect all members of the Eielson AFB community to follow this directive. Military members who fail to follow this directive are subject to disciplinary action. Civilians who fail to follow these directives may be barred from the installation. Updates highlighted.

**COVID-19 Vaccine** The COVID vaccine is available for anyone age 12 or older. Everyone is strongly encouraged to take the vaccine to protect our health, our families, and our community.

2. **354 FW/CC Guidance**

- a. For the purposes of CD 029.1, "Vaccinated Personnel" includes any individual with at least one dose of a COVID-19 vaccine.

- b. **Continued Mitigation Measures:**

- All personnel will wear masks while indoors unless at an individual work station with six foot physical distancing. Personnel may remove masks if required to don PPE or while actively engaging in individual exercise or group physical training with six feet of distancing.
- Must wear masks in vehicles with individuals outside their household.
- Any personnel that experience COVID-19 symptoms, immediately notify the 354 MDG and chain of command.

- c. **Off-base delivery services are permitted as follows:**

- Delivery vehicles must be sponsored on base in-person or by calling the Visitor Center at (907) 377-3807.
- Routine commercial and contractor delivery agencies do not require sponsorship approval.
- Delivery drivers will proceed directly to delivery locations then depart the installation.

- d. **Baker Field House Access:**

- i. An unlimited number of vaccinated personnel may access the Baker Field House and have 24-hr access.
- ii. Only 20 unvaccinated personnel may access the Baker Field House at a time (children under the age of 12 do not count toward the 20-person limit). In the interest of public safety, unvaccinated personnel will not have 24-hr access.
- iii. Vaccinated personnel must show their COVID-19 vaccination-record to gain entry or to register for 24-hr gym access.
- iv. Unvaccinated personnel must provide their DoD ID card upon entry for accounting purposes and retrieve it upon exit.

- e. **Dining/Social Establishments:** Unvaccinated personnel may not utilize on or off-base restaurants or establishments that primarily serve alcohol such as bars or pubs, except for takeout (masks required).

- f. **Leave/Travel:** Unvaccinated personnel must have unit commander approval to travel more than 250 miles from Eielson.

- g. **ISOLATION:** Any person DIAGNOSED with COVID-19 must remain physically isolated until the date directed by 354 MDG and COVID-19 symptoms have resolved.

- h. **QUARANTINE:** Unvaccinated personnel identified by 354 MDG as a "close contact" with a diagnosed COVID-19 individual:

- i. Must remain in quarters for 10 days – starts from last date of exposure as determined by Public Health.
- ii. This is an alternate duty location. Personnel are not on leave.
- iii. 354 FW/CC may adjust quarantine protocols based on mission requirements and assessed COVID-19 risk.
- iv. Fully-vaccinated personnel who are "close contacts" but asymptomatic are recommended to be tested.
- v. **Travel Restriction of Movement (ROM):** All personnel must follow current ROM guidance as outlined (<https://www.eielson.af.mil/coronavirus/>). Additionally, unvaccinated personnel will conduct a 10-day ROM after any Command-approved travel outside of 250 miles from Eielson AFB. Unit commanders may tailor ROM specifications.

- i. **Gathering Size Limitations:**

- i. Eielson-based military personnel may attend gatherings up to 50 persons, on or off-base, with appropriate distancing and mitigation controls in place. Unit commander approval is required for larger gatherings.
- ii. Unit physical training, group physical training, and team sports are authorized and encouraged under the above group size limitations. Masks are required for indoor physical training and sports, regardless of vaccination status, if six feet of distancing cannot be maintained.
- iii. Religious services are exempted from these limitations.
