SUBJECT: Base Access Restriction Guidance

1. Per the 354 FW/CC, the intent of Command Directive 010.1 is to provide guidance on restrictions for base access to reduce the threat of COVID-19. This Command Directive rescinds CD 010. Changes/updates are highlighted.
2. **CC Guidance:**
 - a. The 354 FW/CC has directed any individual (Military, Civilian, Contractor, Dependents, and/or Retirees) will not be allowed access to the installation—until they have undergone a 14-day self-monitoring period—if they meet one of the following criteria:
 - i. Has traveled outside the State of Alaska in the last 14 days
 - ii. Has come in contact with someone who has tested positive for COVID-19
 - b. Anyone experiencing fever, cough, shortness of breath will not be allowed access to the installation until they have met below criteria:
 - i. Self-isolation until at least 7 days since onset of symptoms, three days without fever (without use of medications), and an improvement in symptoms.
 - ii. If individual meets any criteria in paragraph a, they must be quarantined for the full 14 days since return to state of Alaska or from date they were exposed to individual that tested positive.
 - c. Exceptions are as follows:
 - i. If the individual's place of residence for quarantine/isolation is on the installation (i.e. base housing/lodging)
 - ii. If the individual requires treatment/appointment at Eielson's Medical Facilities
 - iii. If the individual has come in contact with a positive COVID-19 patient, while wearing proper PPE, in performance of their official job duties and does not meet any additional criteria from section a or b.
 - iv. The waiver authority for this restriction is the 354FW/CC
 - d. Reference the attached COVID-19 Base Access Flowchart (attachment c) for further guidance/clarification. Commanders are encouraged to distribute this widely to active duty members, dependents, civilians, contractors, and retirees.
